Release and Waiver of Liability for Minors

This release and Waiver of Liability (the “Release”) executed on _____ (dd/mm/yyyy), by _____, a minor child (the “volunteer”) and _____, the parent having legal custody and/or legal guardian of the Volunteer (the “Guardian”) in favour of Guelph & District Multicultural Festival Inc., a non-profit organization and its directors, officers, employees, and agents (collectively “GDMF”)

The Volunteer and Guardian desire that the volunteer work as a volunteer for GDMF and engage in the activities related to being a volunteer. The Volunteer and the Guardian understand that the activities may include interaction with members of the general public.

The Volunteer and Guardian do hereby freely, voluntarily and without duress execute this Release under the following terms:

1. **Waiver and Release:** Volunteer and Guardian do hereby release and forever discharge and hold harmless GDMF and assigns from any and all liabilities, claims and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from volunteer’s work for GDMF.
2. **Medical Treatment:** Volunteer and Guardian do hereby release and forever discharge GDMF from any claim whatsoever that arises or may hereafter arise on account of any first aid, treatment or service rendered in connection with the Volunteer’s work for GDMF or with the decision by any representative or agent of GDMF to exercise the power to consent to medical or dental treatment as such power maybe granted and authorized in the Parental Authorization for Treatment of a Minor Child.
3. **Insurance:** The Volunteer and Guardian understand that, except as otherwise agree to by GDMF in writing; GDMF does not carry or maintain health, medical or disability insurance coverage for any volunteer.
4. **Photographic Release:** Volunteer and Guardian do hereby grant and convey unto GDMF all right, title and interest in any and all photographic images and video or audio recordings made by GDMF during the Volunteer’s work for GDMF, including, but not limited to, any royalties, proceeds or other benefits derived from such photographs or recordings.
